Mayor Meinert called the meeting to order at 5:30 P.M. in Council Chambers, 227 E. Lincoln Avenue, Reed City, Michigan.

**Present** Mayor, Roger Meinert. Council Members: Trevor Guiles, Nicole Woodside, Charles Lupo and Nate Bailey. Dan Burchett and Brad Nixon and were absent. The City Attorney, David Porteous and City Manager, Rich Saladin, were also in attendance. Department Heads attending were, Rich Rehkopf, Kadee Kidd, Chris Lockhart Jeff Stein and Curt Brackenrich. The meeting was opened with the pledge to the flag. There were citizens in the audience.

Dear Council Members,

On December 23, 2024, I purchased the building(s) at the corner of W Upton and Higbee which was formally Century 21 Real Estate office. I am in the process of applying for a Building Communities Grant through the Michigan Economic Development Corporation (MEDC). This grant is to support both this project, to provide a benefit to the community, and build confidence in me as a real estate developer. As part of the grant process, I have successfully completed a course from University of Michigan, "Real Estate Development and Building Value in Your Community". I have learned a lot through this process.

I welcome and encourage you to walk through the building with me. The downstairs has been used as a commercial office space while the second floor has been unused for many years. The second floor is unusable due to the lack of modern electrical, plumbing and mechanical systems. Many of the windows and doors are broken. It is my intent, with the assistance of grant funding and a commercial loan, to convert the property to a mixed-use building. I have attached the preliminary design documents for the upstairs to become a residential apartment (2 bedroom, 1 bath) and the downstairs to be commercial office space which will be renovated to suit the tenant who is already committed. The building has tested positive for asbestos in the stairwell, flooring and window caulking. The heating and cooling systems must be completely replaced. In addition to these issues a portion of the roof may need to be replaced in the near future.

The project has a severe gap in what can be financed due to the expected rate of return. Although there is a need for both commercial office space and residential housing the fair market value of the rent will not cover the scope of the project needed to rehabilitate. The expected budget is \$640,000 which is projected to be paid by loan funds of \$265,000, a grant of \$300,000 and personal investment of \$75,000. This includes the price of acquiring the property.

I believe that the City is aware of the historical significance of these buildings which were once the fire department and City hall for Reed City. Several community members have reached out with inquiries of this building's potential and benefits to our downtown.

I am asking the City to approve the Application for Obsolete Property Rehabilitation Exemption Certificate which would greatly assist in the overall finances of this project. With the projected increase after renovation, combined with the already tight return this would help bring this project to realization.

Please let me know of any questions or if you would like a tour of the project. I look forward to improving the use of this building and hope it will lead to more projects in the future to support our community.

ORDINANCE NO. 001-2025

**AN ORDINANCE TO AMEND THE CODIFIED ORDINANCES OF THE CITY OF REED CITY BY REPEALING AND REPLACING CHAPTER 284 CREATING A DOWNTOWN DEVELOPMENT AUTHORITY FOR THE CITY OF REED CITY, DESIGNATING BOUNDARIES OF THE DOWNTOWN DISTRICT AND PROVIDING FOR OTHER MATTERS RELATED THERETO.**

At a regular meeting of the City of Reed City Council, Osceola County, Michigan, held in the City Hall on the 12<sup>th</sup> day of May 2025, at 5:30 p.m. local time.

PRESENT: Nicole Woodside, Charles Lupo, Nate Bailey, Trevor Guiles and Roger Meinert

ABSENT: Dan Burchett and Brad Nixon

The following ordinance was offered by Bailey and seconded by Guiles.

**THE CITY OF REED CITY ORDAINS:**

**284.01 Title**

This ordinance shall be known as the "Downtown Development Authority Ordinance" of the City of Reed City.

**284.02 Determination of Necessity: Purpose**

The City Council hereby determines that it is necessary for the best interests of the public to create a public body corporate which shall operate to halt property value deterioration, eliminate the causes of that deterioration, increase property tax valuation where possible in the business district of the City, and promote economic growth, pursuant to **PUBLIC ACT 57, PUBLIC ACTS OF 2018, AS AMENDED**.

**284.03. Definitions**

The terms used in this ordinance shall have the same meaning as given to them in Act 57 or as hereinafter in this section provided unless the context clearly indicates to the contrary. As used in this ordinance:

- (a) "Authority" means the Reed City Downtown Development Authority created by this ordinance.
- "Act 57" means **PUBLIC ACT 57, PUBLIC ACTS OF 2018, AS AMENDED**.
- (b) "Board" or "Board of Directors" means the Board of Directors of the Authority, the governing body of the Authority as established by this chapter.
- (c) "Chief Executive Officer" means the Mayor of the City or the City Manager.
- (d) "City" means the City of Reed City, Michigan.
- (e) "Council" or "City Council" means the City Council of the City.
- (f) "Downtown District" means the downtown district designated by this ordinance, as now existing or hereafter amended, and within which the Authority shall exercise its powers.

**284.04 Creation of Authority**

There is hereby created pursuant to Act 57 a downtown development authority for the City. The Authority shall be a public body corporate and shall be known and exercise its powers under title of the "REED CITY DOWNTOWN DEVELOPMENT AUTHORITY". The Authority may adopt a seal, may sue and be sued in any court of this State and shall possess all of the powers necessary to carry out the purposes of its incorporation as provided by this ordinance and Act 57. The enumeration of a power in this ordinance or in Act 57 shall not be construed as a limitation upon the general powers of the Authority.

**284.05 Termination**

Upon completion of its purposes, the Authority may be dissolved by the Council. The property and assets of the Authority, after dissolution and satisfaction of its obligations, shall revert to the City.

**284.06 Description of Downtown District**

The Downtown District shall consist of the territory in the City described in Exhibit A, attached hereto and made a part hereof, subject to such changes as may hereinafter be made pursuant to this ordinance and Act 57.

**284.07 Board of Directors**

The Authority shall be under the supervision and control of the Board. The Board shall consist of the Chief Executive Officer and 8 members. Members shall be appointed by the City Mayor, subject to approval by the Council. Not less than a majority of the members shall be persons having an interest in property located in the Downtown District. Not less than one of the members shall be a resident of the Downtown District, if the Downtown District has 100 or more persons residing within it. Members shall be appointed to serve for a term of four years, except that of the members first appointed, an equal number, as near as is practicable, shall be appointed for terms of 1 year, 2 years, 3 years, and 4 years. A member shall hold office until the member's successor is appointed and qualified. Before assuming the duties of office, a member shall qualify by taking and subscribing to the constitutional oath of office. An appointment to fill a vacancy shall be made by the City Mayor for the unexpired term only. Members of the Board shall serve without compensation, but shall be reimbursed for actual and necessary expenses. The Chairperson of the Board shall be elected by the Board. The Board shall adopt Bylaws governing its procedures subject to the approval of the Council. In the event that the Board determines to employ a Director of the Authority, such Director shall furnish a bond in the **penal sum of One Hundred Dollars (\$100.00)** payable to the Authority for use and benefit of the Authority and shall file the same with the Clerk of the City.

**284.08 Powers of Authority**

Except as specifically otherwise provided in this ordinance, the Authority shall have all powers provided by law subject to the limitations imposed by law.

**284.09 Fiscal Year: Adoption of Budget**

The fiscal year of the Authority shall be the same as the City.

**284.10 Section Headings: Severability: Repeater**

Section headings are provided for convenience only and are not intended to be part of this ordinance. If any portion of this ordinance shall be held to be unlawful, the remaining portions shall remain in full force and effect. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

**284.11. Publication, Recording and Filing**

This ordinance shall be published once after its adoption in full in the Pioneer, a newspaper of general circulation in the City of Reed City and the City Clerk shall file a certified copy of the ordinance with the Michigan Secretary of State promptly after its adoption.

**284.12. Effective Date**

This ordinance shall take effect 30 days from adoption.

**Resolution 2025-06 Approving Obsolete Property Rehabilitation (OPRA) District for Corinna Hervey Located at 201 W Upton Reed City, MI.**

WHEREAS, the City of Reed City legally established the Obsolete Property Rehabilitation District Former Century 21 Real Estate 201 W. Upton on May 12, 2025, after a public hearing held on May 12, 2025; and

\*WHEREAS, the taxable value of the property proposed to be exempt plus the aggregate taxable value of property previously exempt and currently in force under Public Act 146 of 2000 does not exceed 5% of the total taxable value of the City of Reed City; and

WHEREAS, a public hearing was held on the application as provided by section 4(2) of Public Act 146 of 2000 on May 12, 2025; and

WHEREAS, Corinna Hervey is not delinquent in any taxes related to the facility; and

WHEREAS, Corinna Hervey has provided answers to all required questions under the application instructions to the City of Reed City; and

WHEREAS, the application is for Obsolete property as defined in section 2(a) of Public Act 146 of 2000; and

WHEREAS, the applicant Corinna Hervey has provided answers to all required questions under the application instructions to the City of Reed City; and

WHEREAS, the City of Reed City requires that rehabilitation of the facility shall be completed by December 12, 2026; and

WHEREAS, the commencement of the rehabilitation of the facility did not occur more than six months prior to the filing of the application for exemption; and

WHEREAS, the application relates to a rehabilitation program that when completed constitutes a qualified facility within the meaning of Public Act 146 of 2000 and that is situated within an Obsolete Property Rehabilitation District established under Public Act 146 of 2000; and

WHEREAS, completion of the qualified facility is calculated to, and will at the time of issuance of the certificate, have the reasonable likelihood to increase commercial activity, create employment, and increase the number of visitors to Reed City in which the facility is situated; and

WHEREAS, the rehabilitation includes improvements aggregating 10% or more of the true cash value of the property at commencement of the rehabilitation as provided by section 2(j) of Public Act 146 of 2000.

NOW, THEREFORE, BE IT RESOLVED by the Reed City Council of the City of Reed City  
Be and hereby is granted an Obsolete Property Rehabilitation  
Exemption for the real property, excluding land, located in  
Obsolete Rehabilitation District Former Century 21 Real Estate at  
201 W. Upton for a period of 10 years, beginning  
December 31, 2025, and ending December  
30, 2035, pursuant to the provisions of PA 146 of 2000, as amended.
