ORDINANCE NO. 1441

AN ORDINANCE TO ADD CHAPTER 1441 TO PART FOURTEEN, TITLE FOUR, OF THE REED CITY CODE, GOVERNING RENTAL HOUSING

The City of Reed City ordains that:

Chapter 1441 of the City Code is added to Title Four – Housing Code as follows:

1441.01 APPLICABILITY: EXCEPTIONS

- (a) Applicability. This Section shall apply to any dwelling unit or part thereof which is occupied by persons pursuant to an oral or written rental agreement for monetary compensation. These shall include, but not be limited to, single family dwellings, two family dwellings, multi-family dwellings, mobile homes (whether located within or outside of the mobile home park or seasonal home park), boarding houses, and dwellings located in commercial districts C-1 and C-2.
 - (b) Exceptions.
- (1) Multi-family apartment complexes, as long as they remain under the jurisdiction of and/or a financial obligation is owed to an agency such as but not limited to HUD, MSHDA, and FHA.
- (2) Boarding houses that are rented to only persons of the operator's immediate family.
- (3) Transient rental dwelling units such as hotels, motels, short-term rentals (such as VRBO and AirBnB) and bed and breakfast establishments.

1441.02 REGISTRATION

- (a) All buildings or structures within the scope of this Chapter shall be registered with the City Manager, or his or her designee. Registration fees shall be listed in the fee schedule as currently established by the City or as hereafter adopted by Resolution from time to time.
- (1) No person shall occupy rented buildings covered by this Chapter unless the specifically named dwelling has been registered in accordance with this Ordinance and a Checklist has been signed by the occupant.

- (2) No person shall operate or permit occupancy of dwellings covered by this section unless the specifically named dwelling has been registered in accordance with this Ordinance and a Checklist has been signed by the occupant.
- (b) Property owners shall have six months from the Effective Date to register in accordance with this Ordinance.
- (c) Failure to register as required by this Section shall result in a fine as currently established or as hereafter adopted by Resolution from time to time in addition to the initial fee.

1441.03 RENTAL REGISTRATION FORM AND CHECKLIST

- (a) Form contents. When property which has been registered in accordance with this Chapter is rented, the property owner shall file a Rental Registration Form with the City. The form shall include the following information:
 - (1) The name of adult tenants and number of people residing in the rental.
 - (2) Contact information for all adult tenants.
 - (3) The name of the person responsible for paying utilities.
 - (4) A signed checklist on a form furnished by the Reed City Clerk.
- (b) The Rental Registration Form shall be updated whenever there is a change in occupancy of the rental.

1441.05 FEES

Rental Registration fees shall be as currently established or as hereafter adopted by Resolution from time to time.

1441.05 EFFECTIVE DATE.

This Ordinance shall take effect January 1, 2026.
