## City Manager/Zoning Administrator's Report

Rich Saladin reported on the following:

- Received a Tree grant again this year and will look at the end of season to get the best trees for the grant money, must be in ground by November 17, 2024.
- The wells for DWSRF 23' & 24' have been a long-going process. The permits and approval for both wells have been approved. There will be one well house for both wells.
- 220<sup>th</sup>/Patterson Road is going to be done in two phases. Richmond Twp will have their part done first.
- The Todd Avenue project is going well, they are on West Todd now, will be paving soon. Should be done by the beginning of November.
- Lead Service line replacements are being replaced. We are ahead of schedule; the State of Michigan gave us 20 years and we plan on having done in 4 1/2 years. DPW crews are doing a wonderful job and have saved the city a lot of money doing these jobs.

Donna Wheeler says she has heard nothing but great things from people getting new water lines. People are very happy. Wanted The Planning Commission to know she went to Richmond Twp Planning meeting and Richmond Twp hired a lady from GR to do their master plan and she is not familiar with Reed City. There is grant money for Planning Boards.
